#### **SELLING OF BONDS**

RESOLUTION OF THE BOARD OF EDUCATION OF THE BOROUGH OF FORT LEE IN THE COUNTY OF BERGEN, NEW JERSEY DETERMINING TO FINANCE ITS SCHOOL CONSTRUCTION PROJECT THROUGH THE BERGEN COUNTY IMPROVEMENT AUTHORITY AND CONSENTING TO BERGEN COUNTY IMPROVEMENT AUTHORITY'S APPLICATION TO THE LOCAL FINANCE BOARD IN CONNECTION WITH SUCH FINANCING

WHEREAS, on January 24, 2012 the voters of the Borough of Fort Lee approved the bond referendum of the Board of Education of the Borough of Fort Lee in the County of Bergen, New Jersey (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed thereby), which bond referendum authorized a school construction project (the "Project") consisting of HVAC upgrades and roof and window replacement at School No. 1; window replacement and masonry improvements at School No. 3; HVAC upgrades, masonry improvements, and roof replacement at School No. 4; renovation and expansion of Lewis F. Cole Middle School to provide interior alterations, renovations and reconfiguration, HVAC upgrades, roof replacement, additional/renovated educational space, science rooms and media center and site improvements; and improvement of the Fort Lee High School to provide interior alterations, HVAC upgrades, window replacement, masonry improvements and science room alterations, all at a cost not to exceed \$30,206,077 which cost shall be funded in part with a \$9,775,611 grant from the State of New Jersey and in part with the proceeds of the school bonds in an amount not to exceed \$20,430,466 (the "Local Share").

WHEREAS, the Bergen County Improvement Authority (the "Authority") has offered to provide financing for the Board's Local Share through the issuance of certain revenue bonds of the Authority (the "Authority Bonds") the proceeds of which would be loaned to the Board and which loan would be evidenced by a school bond of the Board (the "Board Bond") in the amount not to exceed \$20,430,000; and

WHEREAS, the Authority Bonds would be issued with the benefit of a County of Bergen guaranty which would carry a "AAA" rating which is the highest credit rating available; and

WHEREAS, the County of Bergen's "AAA" credit rating would translate to significantly lower interest rates on the Authority's loan to the Board and as a result, would reduce the amount of interest that the Board would pay on its Board Bond; and

WHEREAS, the Board anticipates that the lower interest costs will result in significant taxpayer savings over the life of the loan; and

WHEREAS, this proposed financing to be undertaken by the Authority and the Board must be reviewed by the Local Finance Board, in the Division of Local Government Services, New Jersey Department of Community Affairs (the "Local Finance Board"), prior to proceeding with the financing of the Project; and

**WHEREAS**, the Authority will be making application to the Local Finance Board for review of the proposed project financing by the Authority through the issuance of revenue bonds in an amount not to exceed \$20,430,000, a proposed bond resolution, a proposed county guaranty ordinance and a proposed county guaranty agreement.

### NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE FORT LEE BOARD OF EDUCATION AS FOLLOWS:

- Section 1. The Board hereby determines to finance the Project through a loan from the Authority to be funded with the Authority's County guaranteed revenue bonds in an amount not to exceed \$20,430,000.
- Section 2. The Board hereby consents to the Authority's application to the Local Finance Board for the proposed financing of the Project by the Authority through the issuance of revenue bonds in an amount not to exceed \$20,430,000.
