ACCEPTANCE OF RECOMMENDATIONS FROM AD HOC COMMITTEE ON HIGH SCHOOL STUDENT CONDUCT

BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Fort Lee Board of Education approves the following **recommendations** from the Ad Hoc Committee on High School Student Conduct:

1. High School "closed campus" lunch

Because operating with an "open" campus at lunch time creates the potential for student behavior issues, we recommend scheduling four lunch periods instead of three, thus creating smaller lunch groups and allowing a closed campus for both 9th and 10th grade students.

2. School Resource Officer (SRO).

Because the Fort Lee Police Department eliminated the position of full time high school SRO last September, one SRO is now shared among all six schools. This level of staffing is inadequate. Police presence prevents many problems from developing and helps to diffuse problems that will naturally arise in any high school. We urge the Mayor and Council to immediately reinstate the position of high school SRO.

3. School security staffing:

The current level of staffing – three persons – is not adequate to provide coverage throughout the school and parking lot. We recommend four full-time personnel assigned as follows – front door/sign in, parking lot, first floor, and second floor, and one part-time person for the cafeteria during lunch times.

4. Security Audit

A full security audit by an outside expert is needed to conduct an independent review of our facilities, equipment (cameras, etc.), policies, and practices. Of these, practices may be the most important. School security is the responsibility of all employees, and an audit may reveal where employee practices can play a larger role in ensuring a safe environment for all.

5. Assign Student Assistance Counselor (SAC) to high school only

This position is currently shared between the high school and middle school. We recommend assigning the SAC to the high school only and having the two middle school counselors take responsibility for the duties of the SAC at the middle school.

6. Freshman Academy

Freshmen account for a disproportionate number of behavior incidents and class failures. To more effectively guide students in the transition from middle school to high school, we recommend adoption of the proposals of the "Freshman Academy" committee of high school staff and parents. These proposals include –

- o Housing freshmen classes in a wing of the school
- o Assigning freshmen lockers in that wing
- o Having staff members assigned to teach 9th grade only
- o Adopting a "family advocate" mentoring program
- o Expanding peer counseling
- o Expanding orientation events and practices
